

**South Lakeland District Council
Submission Core Strategy Representations Statement (Reg. 30)
November 2009 Addendum**

At the request of the Inspector covering the Examination in Public of the South Lakeland Core Strategy, the council was asked to review the classification of representations seeking and/or suggesting a change for the Core Strategy to be considered "Sound", ensuring that such representations are recorded as objections.
