Core Strategy Preferred Options Development Plan Document; and Kendal Canal Head Area Action Plan Preferred Options Development Plan Document

The following details accompany consultation on the South Lakeland Core Strategy Preferred Options and Kendal Canal Head Area Action Plan Preferred Options Development Plan Document, as required by the Town and Country (Local Development) (England) Regulations 2004 (Regulation 26).

PROPOSED TITLES OF THE DEVELOPMENT PLAN DOCUMENTS (DPDs)

1. South Lakeland Core Strategy Preferred Options
2. Kendal Canal Head Area Action Plan Preferred Options

PROPOSED SUBJECT MATTER

1. The Core Strategy DPD provides the overall vision, objectives, spatial development strategy and core policies for the development of South Lakeland up to 2025. The Core Strategy, once adopted, will set out the overarching spatial framework for development and subsequent Development Plan Documents will have to conform to this.
2. The Kendal Canal Head Area Action Plan DPD provides for the possible restoration of a section of the former Lancaster Canal in Kendal, the delivery of a new commercial sector to include a cluster of knowledge-based industries and other canal-based developments complementing and linking with the town centre. The AAP will also explore ways for the delivery of a substantial element of new housing.

PROPOSED AREA

1. The Core Strategy DPD applies to the whole of South Lakeland District, with the exception of the areas lying within the Lake District National Park and Yorkshire Dales National Park.
2. The Kendal Canal Head Area Action Plan DPD applies to the route of the former Lancaster Canal, between Canal Head North and Change Bridge in Kendal, and a number of adjoining sites to the east and west of this route, as defined and mapped in the Preferred Options document.
