The licence holder and/or the designated premises supervisor or a person nominated by them shall actively participate and be a member of a Pub and Club watch scheme for the area within which the premises is located

Bar watch posters and a list of currently banned persons will be displayed throughout the premises.

Posters will be securely fixed and visible to members of the public. Photographs will be made available to employees and displayed in line with the Bar watch constitution. Incidents of crime and disorder / public nuisance that occur on or near to the premise, will be recorded in writing in an incident book retained behind the bar and where appropriate the incident will be reported to the Bar watch committee in line with the Bar watch constitution.

Signs will be located at the exit(s) requesting that customers leaving the premises do so quietly and with consideration to neighbours.

A nominated person will evacuate the outside drinking areas at 10.30pm and will monitor the areas at regular intervals until the end of permitted hours.

The emptying of bottles and pub refuse not to be undertaken after the hours of 10.00 pm, and before the hours of 8.00 am.
