Appendix to Form SL 8 – Section P

a) General - all four licensing objectives.

Hirers and users of the Hall will only serve alcohol as a secondary activity. The Bookings Clerk will ensure that only bookings of this type are allowed. Hirers and users of the Hall will sign an agreement stating that they understand that the sale of alcohol is a secondary activity and that they will abide by our Terms and Conditions.

Our Terms and Conditions are that:

- Alcohol can only be served or supplied and consumed within Victoria Hall main hall and kitchen.
- Hirers must not obstruct the signs on the wall near the bar area, informing the public clearly that alcohol may not be taken out of the Hall.
- Hirers understand that it is unlawful for persons under 18 to purchase alcohol or for any person to purchase alcohol on behalf of a person under 18 years of age.
- There will be signs where they can be clearly seen and read that shall indicate that it is unlawful for persons under 18 to purchase alcohol or for any person to purchase alcohol on behalf of a person under 18 years of age. Hirers must not obstruct these.

The DPS or a delegated member of Grange Town Council staff is on duty at all times when the Hall is in use. In the case of alcohol being sold/supplied, the staff member has the authority to stop the sale/supply of alcohol if they feel the terms and conditions above agreed to are not being upheld. If the DPS is not physically present, they will be available on call and may close the premises if the Licensing Objectives are not being upheld. In the event of the DPS being unavailable to be on call, this duty will be delegated to another post holder within the Town Council.

e) The Protection of Children from harm

Where the purchaser of any alcohol appears to be under the age of 25, alcohol shall not be sold unless the purchaser provides proof of age, by way of a driving licence, passport or a PASS accredited card.
