3. Health / Clinical Commissioning Update.

Clinical Commissioning Group has replaced all Primary Care Trusts & there are now 211 CCG's. All GP Practices are now part of the CCG and have 2 yearly meetings.

Commissioning Support Units have been set up to provide support to all GP's and other clinicians to commission effectively. This support offers a range of functions providing for example: HR, Data control etc. This will be set up until 2016 whilst they work towards becoming independent providers.

NHS England oversees the structures as an independent board accountable to the health secretary. Public Health now moved to the County Council. Public Health England overseas local health providers.

Cumbria CCG have come up with 5 Priorities these are:

- Improve care to respond to challenging ageing population.
- Improve health of Children & Young People & Quality & Integration of Care Services.
- Improve Mental Wellbeing & reduce alcohol misuse.
- Reduce health inequalities & premature mortality disease.
- How we modernise health services. Higher quality of care.

Better Care Together – will cover planned care, urgent/emergency care, maternity and paediatrics.

South Lakeland priorities:

- frail and elderly
- urgent care model
- improve long term conditions
- remodel primary care
- Better Care Together.

4. Draft Strategies for Consideration

- Draft Public Health & Wellbeing Strategy

Functions delivered by the district council will support the reduction of and prevention of individuals requiring health services. The draft strategy sets out the district councils contribution to; encourage adults to stop smoking, reduce alcohol excess, health eating, physical activities and use and access to green spaces.

The council will be also supporting, affordable housing, employment, economic development/growth and safer communities this will reduce fear of crime and also will contribute to the overall health and wellbeing of residents.

The new leisure provider will promote healthy activities across District.

Excessive winter deaths are high in South Lakeland and the council is now working with partners such as green deal and the community switching programme to support families and individuals to reduce their energy bills.

Police: Mark Pannone

"South Lakeland continues to enjoy a reduction in overall crime and antisocial behaviour levels. Serious assaults, criminal damage and dwelling burglaries are showing clear reductions. There is an increase in 'noninjury' assaults which is being monitored, but this is likely to be due to the approach of early intervention and positive action against offenders at an early stage, preventing escalation.

Any member of the group who requires an update on any specific area of crime is welcome to speak to Supt Pannone. Positive work continues with the Community Safety Partnership to address the key areas of crime which are affecting local communities."
