# Introduction

The annual report is designed to provide an insight into South Lakeland District Council's performance, activities, business and finances across the financial year 2015/16.

# April

• Training for landlords

A foundation training course was held for landlords who rent out private properties. The course was held at Kendal Town Hall and was designed to support and inform landlords on how to manage their properties professionally.



#### Lakes Art Project

South Lakeland District Council (SLDC) supported and funded a lakes art project. The project, called Lakes Ignite, was run by Lakes Culture who work in partnership with Cumbria's tourism and cultural organisations to showcase the county as a bright and artistic location. Four specially commissioned works were produced including a paper bridge were produced based on the theme of 'imaginary journeys'.

# Community Infrastructure Levy (CIL)

The new Community Infrastructure Levy (CIL) came in to force. Small builders and home owners, as well as larger developers, were urged to familiarise themselves with the way the charge will work. The charge will affect all new housing development in the South Lakeland district, outside of the National Parks.

# **Our Vision**

Council Plan priorities are considered and refreshed by the council each year. Strategic Development days are held where the vision is reviewed. This process is informed by data collected from the public, intelligence gathered from census data and local partnership working. The vision is to make South Lakeland the best place to live, work and explore. The ambition is to have a prosperous and varied economy with an educated workforce to support it, a balanced housing market with enough affordable housing to meet needs, great leisure services and a cultural offer that appeals to residents and visitors alike.

## • Existing roof revealed at the Castle Dairy

An existing Westmorland green slate roof was revealed on the Castle Dairy, which allowed Archaeologists to collect samples from the core timbers. There is still considerable uncertainty about the dating of the original construction of the building and its subsequent alteration, with some



sources suggesting it was built as early as the 12th century and while others that it was largely a construction of Anthony Garnett in the 1560s.

#### New parish Charter Launch

A new Parish Charter was launched to encourage joint working and better communication between SLDC and parish/town councils. The key aims include:

- improve communications with parish and town councils,
- improve interaction, especially in the planning process,
- increase local councils' understanding of what SLDC does,
- clarify the position around local tax and financial arrangements.

 Free microchipping for pets

SLDC teamed up with Dogs Trust to host events across the district that encouraged dog owners to have their pets microchipped for free.



The event coincided with new regulations as part of SLDC's stray dog enforcement policy.

After April 2016, when the regulation comes into force, any dog the council handles will be scanned and, if it is not microchipped or the details are not up to date, the keeper will be served with a notice. The

keeper then has 21 days to comply with the regulations or face a fine of up to £500.

Providing homes to meet need

The council recognises the disparity between household income and house prices in South Lakeland, and over the last year has been working towards increasing the number of affordable homes. The council continues to focus on delivering 1,000 new affordable homes to rent by 2025 and figures show that the current rate of completion means the council is on target.

#### Celebrating the Magna Carta's 800th anniversary

To mark the 800th anniversary of the Magna Carta, SLDC officers held workshops for young people exploring how the Charter has shaped democracy. Students

from Cartmel Priory Church of England School learned all about Cartmel's link to the Magna Carta and the charter's influence on democracy at the workshops organised by officers, Cartmel Priory Church and the Cumbria County Council Archive Service.

SLDC officers looked at the importance of the Magna Carta in today's society with the students, and how it is still the blueprint for democracy not just for the United Kingdom but for other countries around the world. The students were given the opportunity to create their services and priorities, to ensure the council continues own modern day to meet the most important needs identified by residents. Magna Carta.

> In the main measures of SLDC's performance, value for money and satisfaction with the way things are run, the results show that the council has improved or remained consistent with the 2014 results:

• 40% of respondents agree that SLDC provides value for money (this is up from 29% in 2012 and the same level as 2014).

• More than half the respondents (51%) are satisfied with the way the council we runs things, up from 48% in 2014.

• 42% agree that they can trust SLDC to act in the best interests of the people of Cumbria. When this same question was asked in 2012 35% agreed.

· 88% of respondents also declared themselves satisfied with South

Lakeland as a place to live, and 91% are satisfied with their home as a place to live.

· Around three quarters of respondents (72%) feel strongly that they belong to their immediate neighbourhood.

• Effective waste collection rounds

The Street Scene department commenced a programme to increase the effectiveness of waste and recycling rounds. This involved making changes to



approximately 65% of the district's household waste collection day, equating to approximately 34,000 households. The optimisation of the rounds involved looking at all aspects of the current routes from the number of households served and quantity of waste collected, to the distance from the tipping sites and the times taken to undertake the collections. The aim was to improve the round structures and routes to make the fleet and collection service as efficient as possible and to ensure that the roll out of the enhanced kerbside recycling collections of plastic and cardboard, alongside the other materials, could be continued as effectively as possible. SLDC has extended the enhanced recycling collection service to an additional 5,500 properties in Ulverston and 1,500 properties in Kirkby Lonsdale and are now delivering this service to over 21,000 across the district.

# In 2015/16, did you know?

- 35% of the district will receive plastic and cardboard collections once the service to Ulverston is rolled out.
- By 2019, the amount household waste sent for reuse, recycling and composting is expected to rise to 50%.
- Sky Ride Local has run in South Lakeland, the Central Lakes and Carlisle for the past two years, with almost 1,100 people of all ages and abilities taking part in 115 Sky Rides.
- By 2019, the number of properties where plastic and cardboard recyclables are collected will increase from 13% (38% in 2015/16) to 100% of South Lakeland households.

#### Free business advice support for businesses

Local businesses took advantage of free advice service offered by SLDC. The sessions offered business owners advice in marketing, accounting and writing a business plan.

#### • New enterprise centre opening

Kendal's first enterprise centre supporting start-ups and small businesses opened its doors in November. The MintWorks offers modern, flexible office premises and makes use of a long-standing empty building in the town centre. The initiative was led by Invest in South Lakeland and SLDC's economic development team, which supports inward investment and economic growth.

SLDC participated in a conference with 200 other businesses from the North West to hear about exciting new investment opportunities for South Lakeland. The day generated much interesting discussion and demonstrated the council's commitment to encouraging investment in South Lakeland. Council representatives were on hand to answer planning queries, and a number of successful local businesses were also present to talk about their experiences of doing business in the area.



#### Dementia friendly communities partnership working

Central Lakes Local Area Partnership (LAP) joined forces with Age UK and the Alzheimer's Society to encourage businesses and organisations in the Central Lakes area to be become a Dementia friendly community.

The launch event was held in Ambleside and was an opportunity for business owners, community groups and other organisations to get together, learn about dementia, how to recognise the different symptoms and to consider how environments, locations and communication can be adapted to support those living with dementia.

According to the 2011 census figures the Central Lakes LAP area has seen a 13% increase in its over-65 population since 2001, even though the area has seen an overall 2% population reduction over the same

# O December - flooding



57

South Lakeland suffered severe flooding and disruption during storm Desmond between the 4th and 6th

December 2015, following an exceptionally wet November. In total, some 1,981 residential properties and 580 business properties were affected across 36 Wards. During the emergency, the council operated two emergency reception centres in Kendal, operated the Contact Centre 24/7, supplied over 10,000 sandbags, managed and distributed news and information and helped with the immediate housing needs of 114 families.

As the area moved into recovery, with grants from government the council were able to distribute over 1,500 householder grants, managed over 1,500 Council Tax and rate relief claims, collected and disposed of flood damaged householder property from over 730 properties and is operating the Flood Resilience Grants scheme. The council works as part of a multi-agency emergency response and recovery groups. In addition to flooded properties, impacts were

severe across many parts of the District, particularly the disruption to roads, most noticeably the A591 over Dunmail Raise and (at the time of the flood) the A590

impassable across the Lyth Valley, significantly disrupting communications with the west of the District. Local bridge and road closures continue to create disruption. Local bridge and road closures continue to cause disruption, causing significant repercussions on the economic activity across South Lakeland. The council does not underestimate the impact and uncertainties residents and businesses face in rebuilding their properties. livelihoods and the ability to secure insurance. The council will continue to work with community and business organisations to ensure the needs of residents are understood and appropriate support and assistance is made available. As we move into spring 2016, investigations into the causes of how the flood happened are nearing completion. This will enable future plans to be made which improve the defence and resilience of the area. The council is committed to partnership working in communities to promote and enable local resilience.

## • South Lakeland is 'open for business' following floods

'Open for Business' campaign to encourage visitors to South Lakeland following the flood.

The team visited local businesses to assess how they were coping and to better understand what help was required. An SLDC business advice surgery was held at the MintWorks. More than 30 local businesses attended to speak to representatives from SLDC's economic development, food safety, building control and local taxation teams to get advice on a range of issues from grant support to business rates.

#### • Free car parking in flood hit areas

#### Flood Grant Schemes

SLDC's Revenues team were heavily involved in the aftermath of the flooding in early December.

The team administered three schemes for Council Tax which saw over 1.500 residents receive one-off £500 grant payments. In addition, over 1.200 properties received more than £900,000 in relief from their Council Tax. In addition SLDC has provided relief to over 70 properties which were either vacant or second homes. This equates to in excess of £1.7m in assistance to

residents and home owners in South Lakeland.

Revenues have also administered two schemes for businesses that were either flooded by the events in December or impacted by the damage to infrastructure. So far nearly 300 businesses have shared in a total of over £1.1million of assistance. Relief currently exceeds £1.1m of assistance to nearly 300 businesses.
