Last meeting minutes and matters arising

2. South Cumbria CSP area crime statistics and partner updates

Crime data for South Lakeland and Barrow (Supt. Rob O'Connor)

- Cumbria as a whole is a very safe place to live and South Cumbria is safest area.
- 2017-18 financial year to date: 5% crime increase in South compared to 13% in North and 12% in West.
- Expect increase next year greater focus on reporting including secondary crimes.

SLDC Overview and Scrutiny - CSP performance (Cllr Philip Dixon)

- Discussed concerns about suicide rate in South Cumbria. County suicide prevention group identified as best placed to look at this will be invited to future SLDC Overview and Scrutiny meeting.
- Crimestoppers/County Lines formal feedback at future O&S meeting.

Cumbria Police and Crime Plan Priorities (Supt. Rob O'Connor)

CSP funding application form (Simon Blyth)

• New draft application form and funding terms and conditions will be circulated.

Draft CSP Partnership Plan (Simon Blyth)

- Key priorities: alcohol and violent crime, domestic abuse, CSE and mental health.
- Discussion of numbers killed in road collisions Cumbria steering group best suited to act on this. Will be invited to future meeting.

Community safety for farms booklets (Simon Blyth)

• May need updates to include comments from new Chief Constable - will be shared.

Applied theatre in Cumbria (Simon Blyth)

- Performances planned in 10 schools (7 in South Lakeland and 3 in Barrow) of play on mental health and resilience to year 8 and 9 students.
- Play by Brewery Arts Centre and workshops by Carlisle and Eden/South Lakeland Mind.
- Tuesday 1 May, Theatre performance which will be streamed to rest of Cumbria. Details will be shared.

Police safeguarding hub (Paul Latham)

• Meeting taken to see hub based in police station. Area for number of partners to work together to solve community problems.

CSP event on Mental Health pathways and treatment orders (Simon Blyth)

- Agenda being planned to look at mental health from public health, police and CRC/Probation points of view.
- Aim to improve partnership working to influence interaction with people with mental health issues. Look at what is happening locally, share best practice and assets.
- Ministry of Justice and NHS England leads interested in attending will be invited.

5. Funding

CSP funding position (Simon Blyth)

- 17-18: PCC provided £20K for projects. Spent £10.000 on funding bids (CADAS, the Well, Crimestoppers, Cumbria/Fife Street Neighbourhood Watch, Red Snapper training), printing costs and meeting room hire.
- £10K misidentified as 16-17 ATiC contribution therefore unspent plan to carry forward needs to be linked directly to CSP priorities.
- Update: **now £8,410.53** remaining for carry forward due to below commitments.

Welcome to Cumbria bid (Supt. Rob O'Connor)

- £1188 requested for document to provide translations of legal issues in UK for immigrants in 9 different languages.
- Remainder of £3.5K being sought from North and West CSP. West have not brought to their CSP for decision.
- All approved bid. Draft document will be shared.

South Lakeland Equality and Diversity Partnership bid (Jacquetta Gomes)

- £400 request for booklet providing information on minority faith groups for emergency services in Cumbria. Project will be completed by UCLAN student.
- Remainder of £1200 being sought from North and West CSP.
- All approved bid. Suggestion that a future bid can be made for additional printing costs.

6. South Cumbria CSP sub groups

Alcohol Steering Group (Simon Blyth)

- Recent updates: work by the Well in hospital, statistics from Morecambe Bay CCG, Kendal ICC drug abuse groups linked in.
- Fiona Inston will be returning as chair, Hardeep Burnley has acted as interim.

CSE Steering Group (Supt. Rob O'Connor)

- Significant resources for this work, number of young people identified at risk in Barrow.
- Update can be provided at next meeting.
