We have grounds to believe that the licence holder is not promoting the following licensing objectives:-

- The of Prevention of crime and disorder;
- Prevention of public nuisance; and The protection of children from harm.

In summary, the reasons are - 1) The premises has provided unauthorised licensable activities on more than one occasion. 2) The premises is subject of an ongoing noise nuisance complaint and Mr Knowles is not demonstrating any intention of working towards resolving the matter. 3) It has failed a recent test purchase where a person under the age of 18 was served alcohol. Each licensing objective is dealt with in turn below.

The premises is subject of a complaint relating to noise nuisance caused by musical entertainment held there. This matter has been under investigation since December 2016. Since receipt of the complaint, several face to face meetings have taken place with the premises Licence Holder, Mr Knowles who has been offered advice both in writing and verbally. He has also been provided with assistance in upholding the licensing objectives by a number of the Responsible Authorities including Licensing, Cumbria Constabulary, Environmental Health and Fire Authority. Since the complaint was received more than 18 months ago, the Licence Holder has required a significant level of assistance and intervention with the aim of enabling him to be able to uphold the licensing objectives. Mr Knowles has been provided training materials by Cumbria Constabulary and advice sheets to assist with entries in to the premises incident book. Examples of the advice offered are in the attached letters.

The level of support and intervention required by the Licence Holder exceeds that required by the Licence Holder of any other licensed premises within this controlled District. Despite this, complaints relating to the premises continue to be received by the licensing office. This application is being made because it is considered that Mr Knowles is not able to uphold the Licensing Objectives.

Mr Knowles been advised that his premises is subject of a noise related complaint and that noise nuisance monitoring may take place. A letter dated 28th March 2018 is attached to this application. The letter advises Mr Knowles he has a statutory duty to control excess noise from the premises and that failure to do so could result in restrictions on the ability to operate. He was also advised in writing and during face to face meetings in 2017 and 2018.

As a follow up to the letter sent on 28th March 2018, officers from the Public Protection Department have attended Bowness on Windermere during a number of weekends through May and June 2018. During this period further complaints have been received from a nearby residents and hotels in relation to nuisance caused by noise.

A neighbouring resident has made an official complaint in relation to activities provided by the premises during the weekend of 4-6 May 2018. They are also willing to provide evidence in relation to 27th and 28th May.

Officers from the Public Protection Department also witnessed the premises in breach of its premises licence conditions on the evening / night of Sunday 6th May 2018. During this incident Churchills provided regulated entertainment and failed to comply with the following condition –

All windows and doors to remain closed when regulated entertainment is taking place.

Provision of this activity in contradiction of the condition as laid out above constitute an offence of providing an unauthorised licensable activity. Commission of the offence also undermines the licensing objective "The prevention of crime and disorder".

In order to investigate the breach of this condition Patrick Cantley of the Licensing Authority attended the premises in company with PC Rebecca Hunter of Cumbria Constabulary on 16th May 2018. On attending the premises the CCTV system was not working. PC Hunter subsequently seized the system and submitted it to the imaging unit at Barrow in Furness police station. Upon interrogating the system it was established it had not worked for more than 100 days. During this

period Mr Knowles allowed Churchills to open and provide licensable activities. By doing so he provided unauthorised licensable activities.

On 21^{st} June 2018 Mr Knowles was interviewed under caution at Kendal Police Station in relation to providing unauthorised licensable activities. Whilst stating he is in control of the day to day running of the premises he relinquished all responsibility for its management during weekend of 4^{th} - 6^{th} of May 2018. Mr Knowles,

However, Mr Knowles was seen in person and spoken with on night of 4th May 2018 at the premises by officers from Cumbria Constabulary and the Licensing Authority immediately after a spot premises inspection. Mr Knowles has also confirmed he was present on the premises when officers from the Public Protection Department observed his premises in breach of its licence conditions during the evening and night of Sunday 6th May 2018. In relation to the CCTV system not working Mr Knowles –

- Confirmed the system is located inside his home address;
- Could not recall the last time he had checked to see if it was in working order;
- Was unaware it had been broken for that length of time;
- Went straight out to buy a new system for the premises when he became aware it was broken.

The system was seized from Mr Knowles before he went out to purchase a new one and prior to it being seized had said it was not working for at least a week.

Below is a list of some of the issues in relation to this premises and the relevant licensing objective being undermined.

CCTV system not in working order – **Prevention of crime and disorder.** By allowing his doors to remain open during regulated entertainment he commits and criminal offence. **Prevention of crime and disorder**

Noise emanating from the premises when musical entertainment is provided has triggered complaints from local residents and at least two nearby businesses. **Prevention of public nuisance.**

Failing to appropriately endorse premises incident book – **Prevention of crime and disorder.** Failed test purchase – **Protection of children from harm and Prevention of crime and disorder.** **Please provide as much information as possible to support the application** (please read guidance note 3)

As the licence holder and designated premises supervisor Mr Knowles is responsible for the day to day management of Churchill's. In support of this application I have included some of the "conditions consistent with the operating schedule" of premises licence PL(A)0446. Breach of the conditions constitutes a criminal offence under section 136 of the Licensing Act 2003.

General -

An incident book is kept on the premises to record any incidents, such as alcohol refusals and noise monitoring when regulated entertainment is taking place.

Mr Knowles has been advised repeatedly that he must ensure his incident booklet is appropriately filled. Letters attached to this application lay out the requirement in writing. Mr Knowles has also been advised on at least four occasions during face to face meetings in 2016, 2017 and 2018. Also attached to this application is a premises inspection sheet. The premises inspection was conducted unannounced on 4th May 2018. During the inspection the incident book was checked and found to be poorly endorsed with lengthy periods without anything being written in to the book.

Prevention of crime and disorder -

All staff to be trained with regard to the sale of alcohol and the "Challenge 25" Policy.

The premises failed a test purchase operation conducted by Cumbria Police during the evening of 25^{th} July 2018. The circumstances surrounding the matter are as follows – 2 females aged 15 years and 16 years five months respectively were used as test purchasers. The person making the sale requested to see identification but when the females confirmed they did not have any the person stated they would only be willing to serve the one who appeared to him to look 18 before proceeding to do so.

An email account provided by PC 1794 Rebecca Hunter is attached to this application.

CCTV cameras installed and capable of recording images both inside the premises and outside. These will be retained for a minimum period of 14 days.

On 3rd March 2016 PC 1794 Rebecca Hunter of Cumbria Constabulary sent an email to Mr Knowles to summarise a meeting held at Churchills on 24th February 2016. The email is attached to this application. It clearly advises Mr Knowles regarding compliance with this specific licence condition and that the system was discovered to be faulty in November 2015. In addition to this it was found that the CCTV system was not recording and that there were no cameras installed on the exterior of the premises during the meeting on 24th February 2016.

PC Hunter visited Churchills in company with Patrick Cantley, Licensing Officer, South Lakeland District Council on 16th May 2018. he CCTV system was seized from the premises because Mr Knowles explained it was not working. This was following a request to view CCTV footage in relation to the weekend of 4-6 May 2018 where it was believed Mr Knowles had knowingly failed to comply with conditions on his premises licence intended to further the licensing objective relating to "The prevention of public nuisance.

Following seizure of the system it was sent to Barrow in Furness Police Station where the system was interrogated by Imaging Officer John Burns. Mr Burns confirmed that the system had not recorded any footage since 18th January 2018. Mr Knowles had allowed the premises to open and provide licensable activities during that time and had therefore failed to comply with the condition attached to his premises licence for 118 days.

Letters sent to Mr Knowles by the Licensing Office are attached to this application. He has been

advised repeatedly regarding CCTV in writing and in person. Face to face meetings with Mr Knowles have taken place on the following dates – 1st March 2017 (Multi Agency), 16 March 2017, 17 March 2017 (Noise Monitoring), 1 June 2017, 9 June (Multi Agency), 14 December 2017.

The prevention of public nuisance -

All music is kept to a reasonable level and monitored, this will be documented in the incident book.

All windows and doors to remain closed when regulated entertainment is taking place.

In relation to the above conditions – Churchills has been subject of a noise nuisance complaint received 26/12/16. The complaint initially referred to The White House Hotel which is situated next door and where Mr Knowles is also Licence Holder and DPS. However, as the investigation commenced it became clear that the premises subject of the complaint was Churchills. Since receipt of the complaint in December 2016 a number of face to face meetings with Mr Knowles have taken place. On at least 4 occasions the meetings with Mr Knowles have involved the Licensing Authority, Cumbria Constabulary and Environmental Health.

A nearby resident has recorded video evidence of the premises in breach of the above condition and made a formal complaint. Officers from the Public Protection Department have also observed the premises in breach of this condition.

Mr Knowles has been spoken with about this matter formally. He denied being at the premises on 4th and 5th and then went on to explain that the doors were open because it was hot inside the premises and patrons were fainting. He is currently under investigation for providing an unauthorised licensable activity.

The protection of children from harm -

Proof of age cards are required from anyone attempting to purchase alcohol who appears to be under the age of 25.

The contravention of this condition is laid out above under the objective "Prevention of crime and disorder".

All children to be accompanied by an adult.
