HEDGEROW REPLACEMENT NOICE

ISSUED BY: SOUTH LAKELAND DISTRICT COUNCIL

1. **THIS NOTICE** is issued by the South Lakeland District Council ("the Council") under The Hedgerow Regulations 1997 ("the Regulations") as the Planning Authority because it appears to them that part of a hedge has been removed without the prior consent of the Council

2. THE LAND TO WHICH THE NOTICE RELATES:-

Land under Field Number 0002 in the Parish of Casterton adjacent to Chapel House Lane and the A65 as shown edged red on the attached plan ("the Land")

3. THE MATTERS WHICH APPEAR TO CONSTITUTE THE BREACH OF THE REGULATIONS

Without prior consent from the Council removal of the hedge shown edged blue on the attached plan

4. REASONS FOR ISSUING THIS NOTICE

It appears to the Council that the length of hedge removed has significantly altered the rural outlook causing harm to the amenity in this prominent location of the Parish of Casterton.

The hedgerow served as a wildlife corridor for small mammals and is a source of food for various species of birds and animals.

On the balance of probability the hedgerow is considered an 'important' hedgerow for the purposes of the Regulations.

Prior consent was not obtained from the Council nor would consent be given for removal of the hedge.

5. WHAT YOU ARE REQUIRED TO DO

- (1) Reinstate the hedge using the following specification;
 - Tree species to be reinstated :
 - a. Hawthorn 50%
 - b. Blackthorn 20%
 - c. Ash 10%
 - d. Elder 10%
 - e. Sycamore 10%
 - Tree size to be 40-60cm whips (bare rooted or plugs).
 - Planting to be at a density of 4-6 plants per metre in staggered double rows 40-60 cm apart.

6. TIME FOR COMPLIANCE

The trees to be planted between 1 November 2011 to 31 January 2012

7. WHEN THIS NOTICE TAKES EFFECT

This Notice takes effect on the date of service.


