The other events each employ their own Stewards.

The Sports Day uses Stewards, fencing and gates to ensure the public are separated from anything which may pose a danger. All other events are required to carry out Risk Assessments and have proper stewarding.

d) The prevention of public nuisance

The Annual Sports Day use of stewards has ensured no difficulties of public nuisance in the past. All other events are required to sign up to paperwork to ensure they do the same.

e) The protection of children from harm

The annual Sports Day is child friendly with First Aid facilities provided by St John Ambulance and Ambleside Mountain rescue. All other events are required to have similar arrangements in place.


