

**THE SOUTH LAKELAND DISTRICT COUNCIL
(OFF STREET PARKING PLACES) ORDER 2004
(AMENDMENT NO 15) ORDER 2020**

NOTICE IS HEREBY GIVEN that South Lakeland District Council proposes to make the above Order in exercise of their powers under Section 35 of the Road Traffic Regulation Act 1984 and all other enabling powers, with the consent of Cumbria County Council in accordance with Section 39 (1) of the Act and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act. The effect of which will amend the above-mentioned Order as listed below:

- This Order shall come into force on 1 April 2020 and shall be cited as the South Lakeland District Council (Off Street Parking Places) Order 2004 (Amendment No 15) Order 2020.
- The South Lakeland District Council (Off Street Parking Places) Order 2004 is hereby amended as detailed in the table below.
