b) The prevention of crime and disorder

A CCTV system shall be installed externally at the premises and will meet the following criteria:

- The system will display on any recording the time and date of said recording;
- The system will be recording at all times;
- Any recordings will be retained for a minimum of 28 days after they are made and will be produced to an authorised officer upon request, so long as said request is in accordance with the principles of the Data Protection Act or any subsequent or alternative legislation;
- As a minimum, the CCTV will capture a “head and shoulders” image of any persons entering the premises through the main public entrance.

Appropriate signage alerting customers to the use of CCTV shall be displayed in a conspicuous position at the premises.

The premises will have a written zero tolerance drugs policy which is enforced at all times.

c) Public safety

Housekeeping staff and staff who take bookings for accommodation will be provided with safeguarding training within three months of commencing their employment.

d) The prevention of public nuisance

e) The protection of children from harm

The premises shall carry out age checks upon the booking of accommodation to satisfy themselves that the guests are aged eighteen years or over. Where there is doubt that guests are aged eighteen or over, all alcohol shall be removed from the premises.

Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
 - Live music: no licence permission is required for:
 - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.

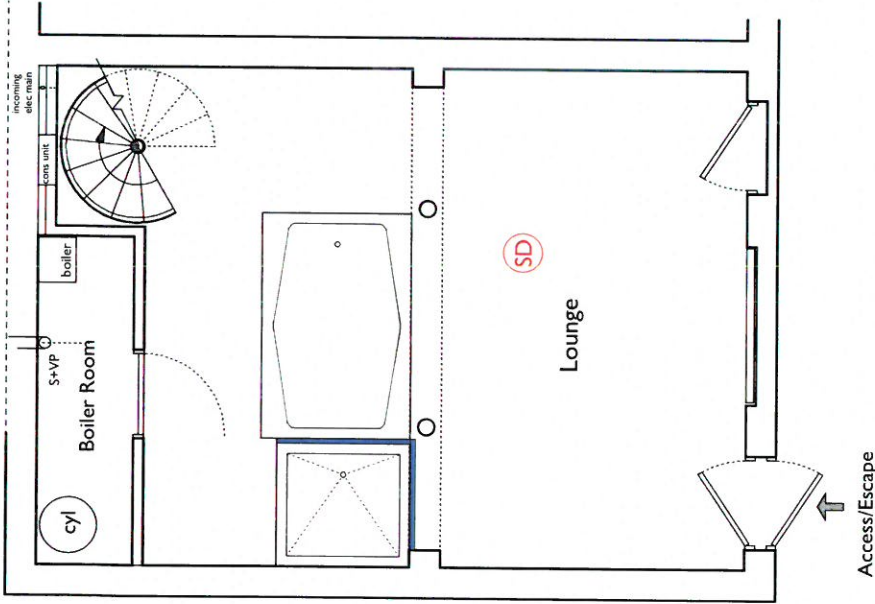

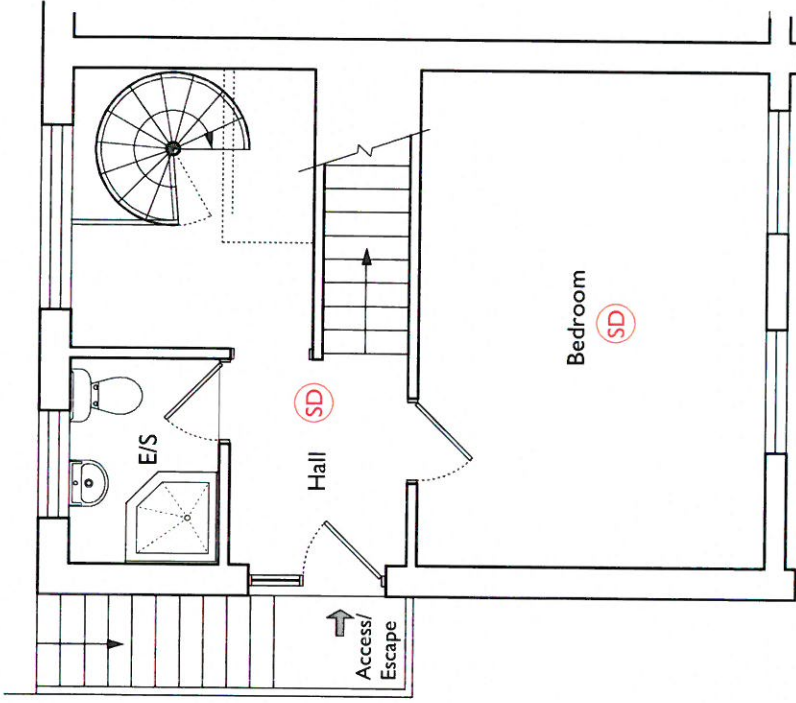

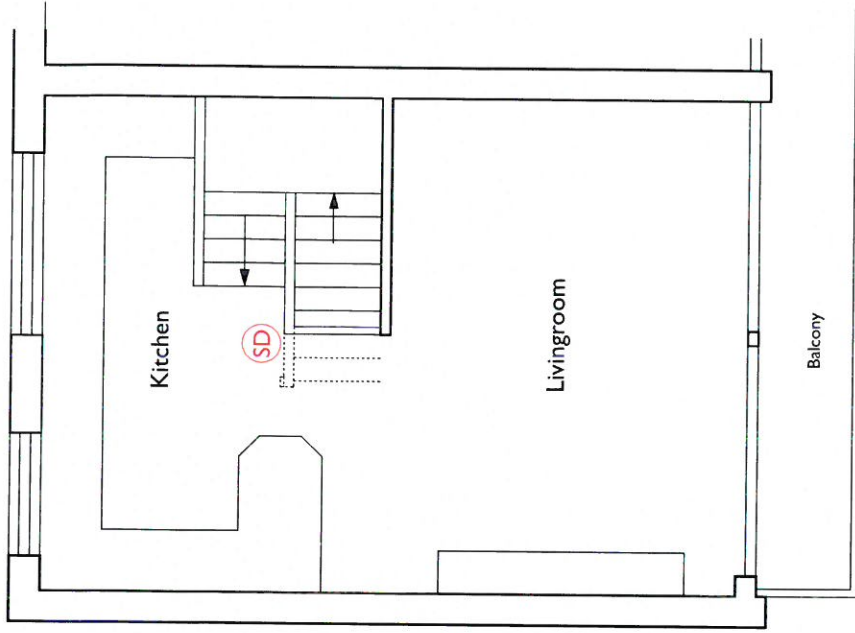
