A documented Challenge twenty five scheme will be operated at the premises. This scheme will be actively promoted & advertised at the premises and will ensure that any person purchasing alcohol, who appears to be under twenty five years of age will be asked to provide acceptable identification to prove they are over 18 years of age.

Failure to supply such ID will result in no sale or supply of alcohol to that person.

CCTV cameras are to be installed.

c) Public safety

Adequate fire safety equipment is in place and regularly checked. Exits are clearly marked and are always open.

d) The prevention of public nuisance

If any customer is causing a public disturbance they will be asked to leave quietly.

Clear and legible notices will be prominently displayed to remind customers to leave quietly

and have regard to our neighbours.
