A digital CCTV camera system shall be used at all times when licensable activities are taking place.

The cameras shall cover the interior and the immediate exterior of the shop and the entrance/exit and alcohol display areas. Images will be retained for a minimum period of 28 days and be made available to the Police and Licensing Authority upon request

The CCTV recording equipment shall be kept in a secure environment under the control of the premises licence holder (PLH) and/or the designated premises supervisor (DPS).

**b) The prevention of crime and disorder**

A digital CCTV camera system shall be used at all times when licensable activities are taking place.

The cameras shall cover the interior and the immediate exterior of the shop and the entrance/exit and alcohol display areas. Images will be retained for a minimum period of 28 days and be made available to the Police and Licensing Authority upon request

Signs will be located at the exit of the premises asking customers to leave quietly

Staff will monitor the area immediately outside the premises on a regular basis to check for, and properly dispose of, any litter.

The shop has in place a Challenge 21 policy. 21 years and who is seeking to purchase alcohol.

Customers attempting to purchase age restricted products who appear to be under the age of 21 years will be required to produce identification in the form of one of the following:

1. Passport
2. Photo card driving licence,
3. Military ID
4. An accredited proof of age card.

A refusals register shall be used to record all occasions where there has been a refusal to sell alcohol and/or other age-restricted goods.

The register shall be kept on site at all times and made available for inspection by authorised officers on request.



**Notes for Guidance**

**This application cannot be used to vary the licence so as to extend the period for which the licence has effect or to vary substantially the premises to which it relates. If you wish to make that type of change to the premises licence, you should make a new premises licence application under section 17 of the Licensing Act 2003.**

1. You do not have to pay a fee if the only purpose of the variation for which you are applying is to avoid becoming liable to the late night levy.

2. Describe the premises. For example the type of premises, its general situation and layout and any other information which could be relevant to the licensing objectives.
