A designated Premises Supervisor has been nominated There will always be a sufficient number of staff on the premises to cover Regular training of staff is continuous with Joey's Café Adherence to 4 objectives as per below.

b) The prevention of crime and disorder

Staff training will be given in accordance with the alcohol rules and regulations, for example we will have documented procedures for staff training, documented records of designated and authorised employee's serving alcohol will be kept.

A record will be kept of any incidents that may occur, refusal and incident reports will be kept. Staff will be aware of the refusal alcohol sales to under age public

c) Public safety

Training and policies, such as Challenge 25, are in place for the safety of both staff and the public.

Bottles, glasses and rubbish to be disposed of safely and removed regularly from public areas. The premises are check daily prior to opening to the public, to ensure safety around the premises.

Health and Safety procedures are followed as standard. All new staff to receive appropriate training. First Aid equipment is always available on site.

All staff to be made aware of their responsibilities regarding selling alcohol.

Fire regulations up to date and maintained.

A check will be kept of the number of people entering and leaving the premises and ensuring that once the maximum occupancy is reached, no further persons are admitted.

d) The prevention of public nuisance

Joey's strongly advocates for responsible drinking and given our location, we have no neighbouring properties, however disposal of bottles and glass will not take place between 11pm and 8am.

Bottles, glasses and rubbish to be disposed of safely and removed regularly from public areas. Suitable and conspicuous notices shall be displayed at entrances and exits requesting patrons to minimize noise and when smoking and/or leaving

Open containers of alcohol shall not be removed from the premises, except for consumption in any delineated external area (licensed area).

e) The protection of children from harm

The safety of children is of the utmost priority for all Joey's cafes.

Bottles, glasses and rubbish to be disposed of safely and removed regularly from public areas. Where necessary, staff will accept Proof of Age Identification, in the form of passport or driving licence.

The licence holder will operate a Challenge 25 Age Verification Policy and display prominent signage indicating that the Challenge 25 scheme is in operation.

 - Live music: no licence permission is required for:
 - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.

 - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.

- A **current** passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity.
- A current Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A **current** Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights or residence.
- A current Immigration Status Document containing a photograph issued by the Home Office to the holder with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A Certificate of Application, **less than 6 months old**, issued by the Home Office under regulation 17(3) or 18A (2) of the Immigration (European Economic Area) Regulations 2006, to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK with the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or reasonable evidence that the person has an appeal or administrative review pending on an immigration decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in the UK including:-
 - evidence of the applicant's own identity such as a passport,
 - evidence of their relationship with the European Economic Area family member e.g. a marriage certificate, civil partnership certificate or birth certificate, and
 - evidence that the European Economic Area national has a right of permanent residence in the UK or is one of the following if they have been in the UK for more than 3 months:
 - (i) working e.g. employment contract, wage slips, letter from the employer,
 - (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,

(iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or

(iv) self-sufficient e.g. bank statements.

Family members of European Economic Area nationals who are studying or financially independent must also provide evidence that the European Economic Area national and any family members hold comprehensive sickness insurance in the UK. This can include a private medical insurance policy, an EHIC card or an S1, S2 or S3 form.

Original documents must not be sent to licensing authorities. If the document copied is a passport, a copy of the following pages should be provided:-

(i) any page containing the holder's personal details including nationality;

(ii) any page containing the holder's photograph;


(iii) any page containing the holder's signature;

(iv) any page containing the date of expiry; and

(v) any page containing information indicating the holder has permission to enter or remain in the UK and is permitted to work.

If the document is not a passport, a copy of the whole document should be provided.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.


