**a) General – all four licensing objectives (b, c, d and e)** (please read guidance note 10)

As the licence holder I shall always ensure when the shop is open for license activities that there are sufficient competent staff on duty to fulfil the terms and conditions of the license and for preventing any crime and disorder on the premises. I will ensure all staff take the necessary training especially in selling alcohol to members of the public, ask for IDs to potential underage drinkers and especially never serve alcohol to drunk persons.

### b) The prevention of crime and disorder

Any incidents of a criminal nature that may occur on the premise will be reported to the police. As a business owner I have already installed CCTV in the shop and can record and play back especially to the police if needed. The CCTV covers all persons entering and leaving the premises and can record up to 24hrs of data. The police will have access to data and images at any reasonable time. As an SIA door supervisor with 20 years' experience, I am familiar in all aspects of deescalating potential crimes and public disorder.

#### c) Public safety

Appropriate fire safety procedures are in place in the shop to include a fire extinguisher, fire blanket, 2 fire and smoke detectors. All appliances are new and have been inspected by the environmental officer giving us a rating of 5. All emergency exits shall be always kept free from obstructions.

#### d) The prevention of public nuisance

All customers will be asked to leave quietly. Signs will be posted in the shop reminding customers to do this, especially regarding the neighbours.

#### e) The protection of children from harm

Both the staff and I (the licensee) will ask all persons who appear under the age of 25 yrs. old for photographic ID such as proof of age cards such as a driving licence, citizen card or passport, an official identity card issues by HM Forces, or by an EU Country, these must bear a photograph and date of birth of the bearer. All staff will be trained for underaged sales prevention regularly. A register of refused sales will also be kept and maintained in the shop.

    - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
