4.4 The tree specimens
are situated in an elevated
position to residential
properties being at a
distance that is just within
falling distance should the
specimens be subject to

windblow. There is no discernible evidence that either specimen will be subject to failure and windblow. Both specimens are in effect, healthy tree specimens. 4.5 The owners of the residential properties have expressed concerns due to the perceived risk as a result of the proximity of the trees and the elevated position. Both Beech specimens and the entire Woodland as a cohesive group, pre-date construction of the residential properties. 4.6 The landowner / tree owner has discharged the legal duty of care and liability in having the trees inspected by a suitably qualified arboricultural consultant on an annual basis. An arboricultural inspection programme that has concluded: There is no case to fell the trees based on actual risk. 4.7 Given the perceived risk, that is, a risk based on opinion and the potential consequences. The residents have made a representation to the landowner requesting the trees are felled.
